1. Hardcopy of Registration form along with a passport size photograph.

2. Self-attested **photocopy of date of birth certificate** from competent authority for submission and **original** birth certificate for verification

3. Service certificate for the candidates of category-I to category-IV

4. **Original caste certificate** of the candidate issued by competent authority in case of a SC/ST/OBC(NCL) for verification and **self-attested photocopy** of the same for verification.

5. FOR BPL-

BPL card, If available in the name of the father of the child, but lapsed as on date, this can be counter signed by BDO of locality for rural areas / executive officers for NAC or municipality areas to validate the card along with any one of the following documents-

a. Antyordaya Arnna Yojana(AAY), card along with low income certificate

b. PHH Ration card along with low income certificate/NGNREGA/Labour card

FOR EWS-

The recent **EWS / Income and asset certificate** in the name of the **parent and the child** (to be produced by economically weaker sections) issued by the competent authority.

6. **Retirement certificate** for uniform defence employees for verification.

7. **Current pay slip** of govt servant in original for verification and self-attested copy for submission

8. **Identity proof** and **address proof in original** for verification. Govt servant should bring the identity card in original issued by their respective departments

9.Nativity/residential certificate/residential proof -

a. **Rent contract** with owner for parents sharing rented accommodation

b. Quarter allotment order in case of govt employees residing in govt quarters

c. **Residence certificate** issued by the competent authority.

10.**Original Aadhar card** of the child for verification and **self-attested copy** of the same for submission.

11.**PH Certificate** for Differently abled students issued by competent authority.

(For DA candidates only)

12. Single girl certificate from Executive magistrate on stamp paper worth Rs 100.

(For SGC candidates only)
